I thank you for your prayers and support of Newman.

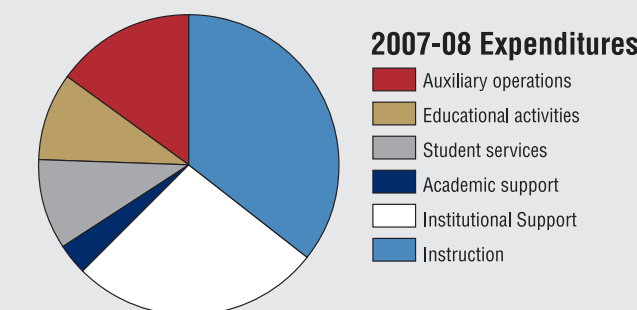
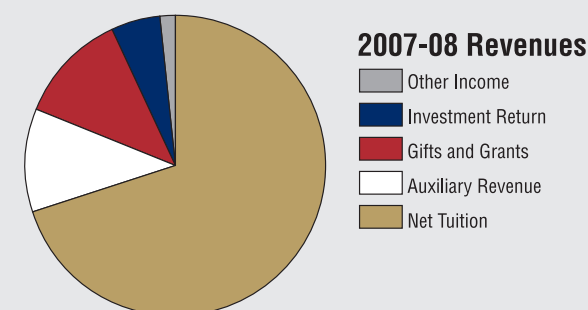
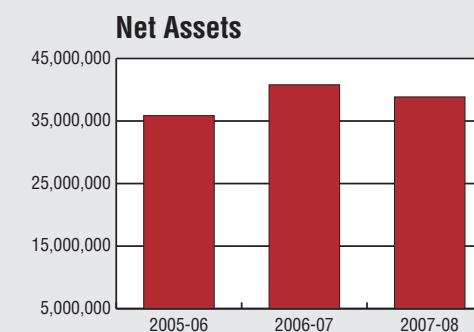
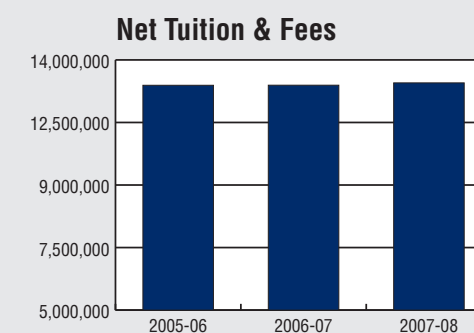
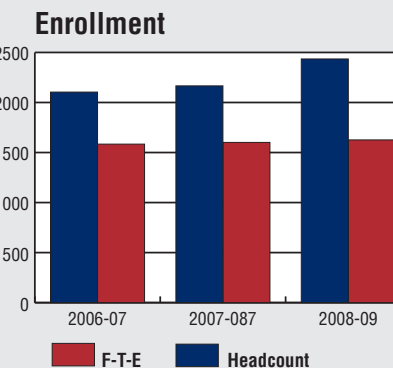
